

A) GENERAL *ELIGIBILITY*:

- i) The candidate must fulfil the age criteria mentioned at S. No 3. Maximum age can be relaxed by 2 years for differently abled children.
- ii) The candidate must be domicile of Union Territory of Jammu & Kashmir.
- iii) The candidates belonging to the reservation categories mentioned at reservation table of admission guideline by NESTS, in respect of their domiciles/Block/District/state/UT are eligible to apply for admission.
- iv) Reservation as per Admission guidelines of NESTS issued **vide F.No: NESTS/EMRS/Admission/140/21-22/1545** Dated: -**11/02/2025** (For class VII-IX & XI).

 90% seats reserved for ST/PVTG/DNT/NT/SNT, 7% for children who have lost their parents to LWE/Insurgencies/COVID/Divyang parents Etc. and 3% for land donors (EMRSs) strictly as per above quoted guidelines
- v) The candidate must fulfil the class qualification criteria mentioned at S.No. 4 & 5, from Government or Recognised Private institution having proper affiliation and shouldn't have completed class in which admission is sought or higher class.
- vi) The candidate should have never been rusticated from any institution.
- vii) Admission secured on the basis of fake/dubious documents or wrong information shall be cancelled and no appeal in such cases shall be considered. In case of any dispute, the decision of Principal EMRS Hubbi/Gurdhanbala shall be final and binding on the candidates.

B) ADMISSION PROCEDURE:

- i) Admission will be strictly done as per the merit in EMRS Lateral Entry Test (EMRSLT) (for class 7th, 8th & 9th) in case the number of applications received for each class surpass the intake capacity/vacancy.
- ii) The EMRSLT, conducted in offline mode, will be of three-hour duration with 100 objective & descriptive type questions from 5 sections for a total of 200 marks.
- iii) The Question Paper of EMRSLT is based on NCERT/SCERT textbooks.
